REGISTRATION FORM for NON-PERMITTED
LARGE CONCENTRATED ANIMAL FEEDING OPERATIONS (CAFOs)

Subsection 81.5 of Colorado Control Regulation 81, as effective on June 30, 2008, requires the operator of a large non-permitted CAFO to register their facility with the Environmental Agriculture Program (Program) by no later than February 27, 2009. The registration must be submitted to the Program and include the following information about the facility:

Latitude / longitude coordinates may be obtained using a GPS unit, mapping software, or another verifiable method. Datum refers to the basis of the coordinates. Typical datums are North American Datum of 1983 (NAD-83) or WGS-84.

(i) Maximum number and type of all animals the facility will confine in the production area:

- Checkboxes for Dairy Mature, Dairy Heifers, Cattle, Calves, Swine (<55lbs), Swine (>55lbs), Sheep, Other (specify), Laying Hens, Other Chickens, Turkey.

(j) A Standard Operating Procedure (SOP) for removal of manure from impoundments in accordance with section 81.8(3). An SOP template can be downloaded from the CDPHE Environmental Agriculture Program website at http://www.cdphe.state.co.us/el/eap.
